

OUR PRE-ELECTION CAMPAIGN

Ireland's fishing industry is in crisis while other EU and non-EU states are seeing strong growth. We face shrinking catches, a reduced fleet, job losses and have less Irish-caught fish for our seafood processing industry. The impact is devastating on coastal communities and service industries. But our Government and the EU fail to address the underlying problem: we have NEVER had a fair share of EU fishing guotas:

- Ireland has one of the largest shares of EU waters 12% yet we are allocated just 5.6% of EU fishing quotas.
- We're allowed to catch just 15% of the fish in our own waters that's 1½ fish in every 10. Other EU
 countries like Spain and the Netherlands, and even non-EU states like Norway, catch the remaining 85%.
- The Netherlands has a coastline of just 450 kilometres. Ireland's is 6 times greater at over 3000 kilometres. Yet in one year alone, their permitted catch in the North East Atlantic was 40% higher than Ireland's.
- A staggering 40% of the fishing quotas given to the UK post-Brexit came from Ireland. So, we have lost 26% of our mackerel quotas, contributing to a 45% loss in pelagic exports last year. We estimate a loss of €8.2m a year in Dublin Bay Prawns by 2026.

Here's our list of suggested questions:

Questions to ask EU Election Candidates & Canvassers
Here are some sample questions with a few useful statistics for you to pick from:

- 1. What is your understanding of the challenges faced by the fishing and seafood sectors and the rapid decline of fishing?
- 2. Ireland has 12% of the EU's fishing waters but gets just 5.6% of EU fishing quotas. As an MEP, how would you advocate for changes to the CFP which would give Ireland a fairer share of quotas?
- 3. We're allowed to catch just 15% of the fish in our own waters. Other EU countries like Spain and the Netherlands, and even non-EU states like Norway, catch the remaining 85%. Do you think this is fair? Would you lobby to change this?
- 4. The Common Fisheries Policy seems to be doing more harm than good for Ireland. What key reforms of the CFP would you press for as an MEP?
- 5. Ireland lost 15% of our quota overnight in the EU's deal with the UK after Brexit. By far the largest share of what was transferred to Britain came from Ireland 40% while just 7% came from Spain, for example. Do you think the EU needs to increase our quotas to address this?
- 6. Are you prepared to give a voice to our fishing and seafood sector, defend our interests and work to influence future deals and policy decisions at EU and Fisheries Council level which will help us grow?
- 7. In particular, would you urge our Government to veto EU decisions which are unfavourable to Ireland's fishing industry?
- 8. What issue or issues which are affecting Coastal Communities would you like the EU to prioritise
